5.3. The age of the participant is determined on the day of the competition.

5.4. The admission Commission and the judging seminar will be held on 25.06.2021 at the address of the competition venue: Krasnodar Territory, Anapa resort city, Vityazevo village, Yuzhny Prospekt, 20, Vityaz Sports Complex.

6. REQUIREMENTS FOR PARTICIPANTS OF COMPETITIONS AND CONDITIONS OF THEIR ADMISSION

6.1. National teams of national organizations and invited partner teams are allowed to participate in the competition. Participants of the events must meet the qualification requirements, know the rules of the competition, pass the admission commission.

6.2. The numerical composition of the team: the official representative of the team, the judge, the athletes.

6.3. Team representatives must have and submit 25.06.2021 to the admission commission for each athlete:

6.3.1. personal performances (offline);

a) the passport of the national organization or a copy of the passport or birth certificate;

b) team application, parental consent to participate in the competition, payment receipt for participation (Appendices 1,2,3).

6.3.2. remote (online) performances (send by 20.06.2021 in electronic form by e-mail to kaseha@yandex.ru):

a) a copy of the passport of the national organization or a copy of the passport, birth certificate;

b) video recording of the performance (front-end recording, no more than 25 MB)

c) photos: participant (color, in karategi with the organization's logo, full-length), coach and judge (color, in a suit with the organization's logo, portrait);

d) a photo or scan of the payment receipt for participation.

6.4. Each participant admitted to the competition must have:

- technical qualification 6 -12 years – from 10 kyu, 12-17 years – from 8 kyu, 18 years+ from 7 kyu.

- karategi of white color with the emblem of the national organization and a belt of the corresponding technical qualification;

- red and white belts;

- protective equipment: white hand pads (required), groin, chest and mouth guard (recommended) .

7. AWARD CEREMONY

7.1. The winners and prize-winners of the competitions (1st, 2nd and 3rd places) are awarded with medals and diplomas of the corresponding degrees provided by the Russian Karate-do Union Shotokan Kase Ha LLC

7.2. Additionally, prizes can be set by sponsors and other organizations.

8. TERMS OF FINANCING

8.1. Financing of expenses for the preparation and holding of competitions: purchase of award attributes, production of advertising and commemorative products-is provided at the expense of the Russian Union of Karate-do Shotokan Kase Ha LLC.

8.2. Secondment of athletes, coaches and referees (travel in both directions, food, accommodation, insurance) - is provided at the expense of the sending organizations.

8.3. Voluntary contributions:

8.3.1. general training BUDO ACADEMY-1500 rubles per participant / the price includes the branded T-shirt of the event /;

8.3.2. judging seminar-without payment / karate gi uniform /;

8.3.2. conducting competitions – 20 US dollars per participant in each type of program;

8.3.3. absence of a judge, filing a protest – 50 US dollars ;

8.4. Payment of the fee is made by bank transfer according to the details of the Russian Karate Union-do Shotokan Kase Ha (Appendix No. 3) with the wording – "voluntary contribution" or is made when passing the admission commission.

9.1. The application deadline is June 20, 2021. Changes to the application are accepted no later than June 23, 2021.
