1. CLASSIFICATION OF COMPETITIONS

- 1.1 International competition "II OPEN KASE CUP-2022" Karate Do Shotokan Ryu Kase Ha (hereinafter referred to as "competition") is held according to the plan of events of the OSOO "Russian Karate-Do Shotokan Kase Ha Union" for the academic year 2022.
- 1.2 Aims and objectives of the competitions:
 - 1.2.1. Formation of regional teams of the International School Karate Do Shotokan Ryu Kase Ha for the participation in the First World Championship (May 01, 2022, Russia, Bryansk), II Open Asian Cup (May 08, 2022, Tajikistan, Dushanbe), III European Cup (June 19, 2022, Russia, Anapa), III Eurasia Cup (August 7, 2022, Abkhazia, Sukhum).
 - 1.2.2 Improvement of participants' skills to pass regional, national and international technical examinations of WKS KASE HA UNION;
 - 1.2.3 Development and popularization of the World Karate Do Shotokan Ryu Kase Ha Union (WKS KASE HA UNION).

5.3 Participant's age is defined at the day of competition.

6. REQUIREMENTS TO COMPETITORS AND CONDITIONS OF THEIR ADMISSION

6.1 National teams of regional clubs and organizations, invited teams of partners are allowed to participate in competitions. Participants of events must meet the qualification requirements, know the rules of the competitions, pass the commission for admission.

6.2 Team leaders must send by 18.01.2022 electronically via e-mail to kaseha@yandex.ru:

a) passport number of the national organization or a copy of passport, birth certificate;

b) application form of the team for participation in the competition, a receipt of payment for participation (Annexes 1,2).

c) one video recording of the performance according to the competition program (frontal recording, not more than 25 MB);

d) if possible to put the recordings to the disk <https://drive.google.com/> with the signature: "KM 16, DANIL IVANOV 1 DAN, HEIAN 5, RUSSIA, KURSK" / 16 years old male kata, Daniil Ivanov 1 Dan, HEIAN 5, Russia, Kursk/.

6.3 Each participant admitted to the competition must have

- technical qualification 6 -12 years - from 10 kyu, 12-17 years - from 8 kyu, 18 years+ from 7 kyu (demonstration of kata according to their technical level and one step higher).

- Karate gi white color with the emblem of the national organization and a belt of appropriate technical qualification (advertising inscriptions on the uniform of participants are prohibited).

7. GIFTING

- 7.1 Winners and prize-winners of the competitions (1st, 2nd and 3rd places) are awarded by medals and diplomas of the corresponding degrees provided by the NGO "Russian Karate-do Shotokan Kase Ha Union".
- 7.2 Additional prizes may be presented by sponsors and other organizations.

8. TERMS OF FINANCING

- 8.1 Financing of expenses for preparation and conducting the competitions: purchase of awarding paraphernalia, manufacturing of advertising and memorable products - is provided at the expense of the OSOO "Russian Karate-do Shotokan Kase Ha Union".
- 8.2 Payment for the judges' work (certified judges according to the decision of the Presidium) - is provided at the expense of the "Russian Karate-do Shotokan Kase Ha Union".
- 8.3 Voluntary fees:
- 8.3.1. judging seminar – 20 doll USA (certified judges without payment), the official form WKS KASE HA UNION;
- 8.3.2. competition holding – 20 doll USA per participant in each type of program.
- 8.3.3. protest filing – 50 doll USA .
- 8.4 The fee is paid by bank transfer to the details of the NGO "Russian Shotokan KASE HA Union" (Appendix № 2) with the wording - "voluntary fee" and sent to e-mail: kaseha@yandex.ru before the Commission for admission.
