1. CLASSIFICATION OF COMPETITIONS

- 1.1 Competitions are individual and team competitions.
- 1.2 Aims and objectives of the competitions:
- 1.2.1 Identification of the strongest athletes in Karate Do Shotokan Ryu Kase Ha.
- 1.2.2 Increasing the skills of the participants;
- 1.2.3 Development and popularization of the World Karate Do Shotokan Ryu Kase Ha Union (hereinafter WKS KASE HA UNION).

- 5.4 Admission committee and referee seminar will be held on 04.11.2022 at the place of the event.

6. REQUIREMENTS TO PARTICIPANTS OF COMPETITIONS AND CONDITIONS OF THEIR ADMISSION

- 6.1 National teams of WKS KASE HA UNION are allowed to participate in competitions. Participants of events must participate in the XXII international training camp, must meet the qualification requirements, know the rules of the competition, pass the commission for admission.
- 6.2 The numerical composition of the team: official representative of the team, referee, athletes.
- 6.3 Team representatives must have and present to the admission committee for each athlete:
- a) passport of the national organization;
- b) application form of the team signed by the doctor, the parental consent to participate in the competition, the payment receipt for participation (Appendices 1,2,3).

Each participant admitted to the competitions must have

- technical qualification 6 -12 years from 10 kyu, 12-17 years from 8 kyu, 18 years + from 3 kyu (according to international registries of websites : www.kasehaworld.com, www.shotokan.com.mx, kaseha.ru).
- Karategi white color with the emblem WKS KASE HA UNION and a belt of appropriate technical qualification;
 - belts of red and white color;
- protective equipment: white hand pads and mouth guard (mandatory), groin and chest protection (recommended).

7. REFERENCE

- 7.1 Winners and prize-winners of competitions (1, 2 and 3 places) are awarded by medals and diplomas of corresponding degrees provided by the ISO "World Karate Do Shotokan Ryu Kase Ha Union".
- 7.2 Additional prizes may be established by sponsors and other organizations.

8. CONDITIONS OF FINANCING

- 8.1 Financing of the preparation and conducting of competitions: purchasing the prize symbols, production of advertising and memorable products is provided by the ISO "World Karate Do Shotokan Ryu Kase Ha Union".
- 8.2 The sending of athletes, coaches and judges (round trip travel, food, accommodation, insurance) is provided at the expense of the sending organizations.
- 8.3 Voluntary contributions:
- 8.3.1. national training fee (general course and master course) 25 USD per participant;
- 8.3.2. judicial seminar 15 USD (participants of the master course without payment), karate uniform;
- 8.3.2. conducting the competition 25 USD per participant in each type of program.
- 8.3.3. absence of a judge, filing a protest 100 USD.

8.4 Payment of the fee is made by bank transfer to the details of the ISU "World Karate Do Shotokan Ryu Kase Ha Union" (Appendix № 3) with the wording - "voluntary fee" or made when passing the commission for admission.
